



Notes to the financial statements

Accounting Policies

The financial statements have been prepared under historical cost convention.

Financial Reporting Standards Number 1

Exemption has been taken from preparing a cash flow statement on the grounds that the company qualifies as a small company.

1. Turnover

Turnover represents net invoiced sales of services, excluding VAT

2. (Loss)/ Profit on Ordinary Activities

No items were charged at the (Loss) Profit on Ordinary Activities which need to be disclosed.

3. Taxation

The Directors consider that the Society should be treated for Corporation Tax purposes as being mutually trading and is not liable to UK Corporation Tax.

4. Investments in Shares

The Trust owns 7,025 (2011: 6,875) ordinary shares of 10p each in Hampton & Richmond Borough FC Ltd at a total cost of £8,001 (2011: £5,001). The Trust acquired a further 150 shares at a cost of £3,000 during the financial year ended 31 August 2012.

The shares are not easily transferable and in the opinion of the Society board have negligible value so the cost of shares is expensed to the profit and loss account.

5. Creditors: amounts falling due within 1 year

6. Called Up Share Capital

Each full member of the Society owns one ordinary share of £1 which is not transferable. The share is cancelled if an individual ceases to be a member.

Junior members cannot hold shares in the Society nor have any voting rights.
